The RCA from Hunters Point Recycling has multiple issues. Section 2 question two asks if the gradation meets the requirements to not require sampling. Based on the attached gradation report, ~34% of the material passes through the 80 mesh sieve. The third question asks if virgin material is from a permitted mine or quarry. Hunter Point Recycling is a recycling center and not a permitted mine or quarry. Since the material does not meet the sampling exemption, section 3 will have to be modified to include the sample results. The permit attached from the NYC Department of Sanitation is expired.










Spill Area in Equipment Staging Area (Northeastern Portion of Yonkers Site)




