Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the Kensico Drive and Kisco Avenue Properties site ("site") located at 15 Kensico Drive, 19 Kensico Drive, and 275 Kisco Avenue, Mount Kisco, Westchester County. Please see the map for the site location.

Draft Investigation Work Plan: The draft investigation work plan, called a "Remedial Investigation Work Plan," (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by 275 Kisco, LLC, 19 Kensico Drive, LLC, and 15 Kensico, LLC ("applicants") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

How to Comment: NYSDEC is accepting written comments about the Draft RIWP for 30 days, from **June 26 through July 26, 2024**.

Highlights of the Proposed Site Investigation: The investigation will define the nature and extent of contamination in soil, groundwater, soil vapor and any other parts of the environment that may be affected.

Previous investigations have detected volatile and semi-volatile organic compounds (VOCs and SVOCs), metals, and PCBs in soil and groundwater on site.

Key components of the investigation work include:

- Drilling and sampling of soil borings to identify possible on-site sources of contamination;
- Collection of soil vapor, sub-slab soil vapor, and indoor air samples; and
- Installation and sampling of groundwater monitoring wells to assess the nature of groundwater contamination both on-site and off-site areas.

Next Steps: NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan.

NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a "Draft Remedial Action Work Plan" will be developed. The cleanup plan will include an evaluation of the proposed site remedy, or recommend a no action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description: The site is 7.40 acres, comprising of three lots bound by Kisco Avenue to the west, Holiday Inn Drive and Suburban Propane to the north, Metro North's Harlem Line to the east, and a Toyota dealership and Halstead-Quinn propane facility to the south. It is currently developed with a car dealership and service center at 275 Kisco Avenue, a commercial woodworking and cabinetry facility at 15 Kensico Drive, and a car wash and storage facility at 19 Kensico Drive inactive since 2021. Previous site uses include manufacturing of copper pipe at 275 Kisco from 1953 to 2011 and at 19 Kensico Drive from 1949 to 1971, an auto service center at 15 Kensico Drive from 1981 to 2004, and a beverage and bottling facility at 19 Kensico Drive from 1972 to 2005.

The planned redevelopment is car maintenance and storage facilities at 15 and 19 Kensico Drive, and continuation of the car dealership at 275 Kisco Avenue. The anticipated cleanup standard is to commercial and industrial use based on current and future site use and zoning.

A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.


