Remedy Proposed for Brownfield Site Contamination; Public Comment Period Announced

The public is invited to comment on a proposed remedy being reviewed by the New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH), to address contamination related to the Lofts at 1117 site (site) located at 1117 West Fayette Street, Syracuse, Onondaga County. Please see the map below for the site location.

Based on the findings of the investigation, NYSDEC, in consultation with NYSDOH determined that the site does not pose a significant threat to public health or the environment. This decision is based on the absence of a source area present at the site and the low potential for off-site migration of contaminants in the groundwater. NYSDEC developed the proposed remedy summarized below.

How to Comment: NYSDEC is accepting written comments about the proposed plan, called a draft remedial action work plan for 45 days, from **October 9th through November 23rd, 2024**.

Draft Remedial Work Plan: The proposed restricted residential use remedy consists of:

- Excavating approximately 340 cubic yards of contaminated soil from three areas in the central and eastern portions of the site and disposing offsite.
- Collecting and analyzing post-excavation soil samples to evaluate the effectiveness of the remedy.
- Placing a cover system, including a demarcation layer, over areas without existing hardscape (buildings, asphalt, or concrete), to address contamination remaining above restricted residential use soil cleanup objectives.
- Importing clean material that meets restricted residential soil cleanup objectives for use as backfill.
- Evaluating the potential for soil vapor intrusion in the two redeveloped site buildings.
- Implementing a Health and Safety Plan and Community Air Monitoring Plan during all ground intrusive activities.
- Implementing a Site Management Plan for long-term maintenance of the remedial systems.
- Recording of an environmental easement to ensure proper use of the site.

BROWNFIELD CLEANUP PROGRAM

The proposed remedy was developed by BNZ1117, Case1117, and Dannan Reality, LLC (applicants) after performing a detailed investigation of the site under New York's Brownfield Cleanup Program. A remedial investigation report, which describes the results of the site investigation, was submitted previously and is also available for review at the locations identified on Page 1.

Next Steps: NYSDEC will consider public comments, revise the cleanup plan as necessary, and issue a final decision document. NYSDOH must concur with the proposed remedy. After approval, the proposed remedy becomes the selected remedy. The applicants may then design and perform the cleanup actions to address the site contamination, with oversight by NYSDEC and NYSDOH.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description: The approximately 0.46-acre site is bordered on the west by a parking lot, on the south by a shopping plaza, on the north by West Fayette Street, and on the east by a mixed-use building. The site was most recently used for commercial purposes and is currently vacant. The site and surrounding areas are served by a municipal drinking water source.

Proposed redevelopment will include rehabilitation of existing buildings and creation of residential apartments. The cleanup standard is restricted residential to allow for multifamily housing.

Summary of the Investigation: The primary contaminants of concern found at the site are lead and mercury in soil. The majority of these soil contaminants are present near the center and eastern portions of the site. Carbon tetrachloride

was also found in soil vapor and in air in the northernmost portion of the two existing site buildings.

Brownfield Cleanup Program: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business, or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
