Hi Aron,

I have completed my review of the Interim Remedial Measures Work Plan - Amendment #2 for the Former Sperry Remington Site #C808022 dated 12 Sept. 2017 and approve contingent upon the following:

- any material moved from the BCP site must first have Department approval for reuse at the site.
- the Beneficial Use Determination for Asphalt Millings described in Table 1 did not include use beneath the tennis courts.
  - based on chemical testing, a request for reuse of Asphalt Millings **below an approved cover system** was granted 25 Sept 2017
    - pending approval from the ECSD, the asphalt millings may be used over clean remediation backfill in the tennis court area, provided a demarcation layer is first installed.
- based on chemical testing, a request for reuse of Stockpiled Topsoil **below an approved cover system** was granted 25 Sept 2017.
- the final locations and depths of reuse of these soils will be documented for site management purposes.

Please notify the Department at least 48 hours in advance of Amendment #2 activities.
