WHEREAS, the New York State Department of Environmental Conservation (the Department) and Conifer Hamilton, LLC (Existing Applicant) entered into a Brownfield Site Cleanup Agreement, Index #B8-0673-04-08N (the Agreement), which Agreement was signed by the Commissioner of the Department on December 2, 2004 relative to property located at 185 Mount Hope Ave. in the City of Rochester, County of Monroe (the Site); and

WHEREAS, Genesee Hamilton, L.P.(Applicant) by a certified application dated May 6, 2008 has applied for a change in party replacing the Existing Applicant, Conifer Hamilton, LLC, with Genesee Hamilton, L.P.; and

WHEREAS, upon consideration of the factors enumerated in ECL 27-1407(8) and (9), the Department made a determination, based upon the information contained in the application and the certifications made by the Applicant that the Applicant is eligible to participate in the Brownfield Cleanup Program as a Volunteer as defined in ECL 27-1405(1)(b); and

WHEREAS, the Existing Applicant and the Applicant agree to be bound by the terms of this Amendment and consent and agree not to contest the authority or jurisdiction of the Department to enter into or enforce this Amendment, and agree not to contest the validity of this Amendment:

**NOW, THEREFORE**, IN CONSIDERATION OF AND IN EXCHANGE FOR THE MUTUAL COVENANTS AND PROMISES, THE PARTIES AGREE TO THE FOLLOWING:

I. The third paragraph of the Agreement is hereby amended by deleting the third paragraph and substituting the following:

WHEREAS, by a certified application dated May 6, 2008, Genesee Hamilton, L.P., a limited partnership, having offices at 183 Main Street 6<sup>th</sup> Floor, Rochester, New York 14604, submitted a request to participate in the Brownfield Cleanup Program relative to property located at 185 Mount Hope Ave. in the City of Rochester, County of Monroe (the "Site"); and

- II. This Amendment shall control to the extent of a conflict between the provisions hereof and those of the Agreement. Except as provided in the preceding sentence or elsewhere in this Amendment, the Agreement and the documents related thereto, shall continue in full force and effect. Any amendment or other modification of this Amendment must be in writing.
- III. The effective date of this Amendment shall be the date on which it is signed by the Commissioner or the Commissioner's designee.
