On behalf of DuPont CRG, Parsons is pleased to provide this monthly progress report summarizing the project activities performed during April 2011 pursuant to the requirements of the Brownfield Site Cleanup Agreement for the 666 Driving Park Site located in the City of Rochester, NY.

Inspections at this site began on June 2, 2008. Site inspections, as requested by New York State Department of Environmental Conservation (NYSDEC), will continue to be made weekly to assess the integrity of the site fence and make repairs as needed. Reports from the four inspections completed during April are attached. One fence area was observed during April to warrant repair, and the repair was completed.

DuPont submitted to you in late December the Remedial Alternatives Analysis Report which you received during the first week of January. To date, we have not received approval or comments on this report. Please contact Paul Mazierski of DuPont when the Department has completed its review.
