Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the Hawkeye Trade Center and Residences – 1A site ("site") located at 1447 St Paul Street, Rochester, Monroe County. Please see the map for the site location. Documents related to the cleanup of this site can be found at the locations identified to the left under "Where to Find Information."

<u>Draft Investigation Work Plan</u>: The draft investigation work plan, called a "Remedial Investigation Work Plan," was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by WBS Capital, Inc. ("applicant(s)") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

<u>How to Comment</u>: NYSDEC is accepting written comments about the draft investigation work plan for 30 days, from **January 1** through **January 31, 2020**. The proposed plan is available for public review at the location(s) identified at left under "Where to Find Information." Please submit comments to the NYSDEC project manager listed under Project-Related Questions in the "Who to Contact" area at left.

<u>Highlights of the Proposed Site Investigation</u>: The investigation will define the nature and extent of contamination in soil, groundwater, and any other parts of the environment that may be affected.

Previous investigations have detected volatile organic compounds (VOCs) in groundwater, sub-slab soil vapor, and indoor air.

Key components of the investigation work include:

- Sampling surface and subsurface soil to identify possible on-site sources of contamination;
- Sampling soil vapor at the site perimeter to evaluate the possibility of soil gas migrating off-site;
- Investigating a former thorium glass settling pit located in the central portion of the site; and
- Installing and sampling groundwater wells to monitor impacts from contaminated areas of concern.

Next Steps: NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

When the investigation is completed, a report will be prepared and submitted to the NYSDEC that summarizes the results. NYSDEC, in consultation with NSDOH, will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a site cleanup plan, called a "Remedial Work Plan" will be developed and a Decision Document will be proposed. The cleanup plan will include an evaluation of the proposed site remedy, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

<u>Site Description</u>: The site is 1.7-acres and is bordered on the north by a school, the south and west by former Kodak buildings, and the east by a parking lot and residences. The site is currently developed with four vacant buildings and a parking lot. The site was historically utilized as a metal stamping and plating facility, machine shop, and photographic production facility since approximately 1911.

Brownfield Cleanup Program: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
