



Dear Mr. Caranci:

As you know, Sarah-Frank, LLC is currently the owner of the properties located at 75 Booth Street and 24-30, 130 and 158 Lakeshore Drive in the City of Canandaigua (collectively referred to as the "Project Site"). We are aware that the following entities will be investigating, remediating and/or redeveloping parcels comprising the Project Site during future project phases: Morgan-LeChase Development, LLC; Canandaigua Lakefront LLC; North Shore P1 LLC; North Shore P1A LLC; North Shore P2 LLC; North Shore P3 LLC; North Shore P4 LLC; and North Shore P5 LLC (collectively referred to as the "Entities").

Since the Entities do not yet own any of the parcels comprising the Project Site, but are, along with Sarah-Frank, LLC, the BCP Volunteer, committed to remediate the Project Site, the Entities are required to seek written access from Sarah-Frank, LLC for the purpose of performing environmental investigation and remediation work as a criteria for acceptance into the BCP. By executing below, I am acknowledging that I have authority to execute this consent on behalf of Sarah-Frank, LLC, and to provide the Entities with full and complete access rights to the Project Site to perform environmental investigation and remediation work required by the New York State Department of Environmental Conservation at the Project Site. Therefore, on behalf of Sarah-Frank, LLC, which is the owner of the Project Site, I agree, as member with authority to execute such consent, to allow the Entities and their contractors, consultants, subcontractors and agents, to enter the Project Site to perform the required Brownfield Cleanup Program investigation and remediation work, as well as all applicable redevelopment construction activities during future project phases.
