City of Geneva, Ontario County**

The Department has completed its review of the document entitled "Remedial Action Work Plan," dated May 2017 and has determined that the report addresses the requirements of the Brownfield Cleanup Agreement and the Department's comments previously provided. This document is hereby approved. Except for the Community Air Monitoring Plan, this approval does not extend to the Health and Safety Plan, as the Department is not responsible for the health and safety of remediation workers.

A copy of the approved document is required to be kept in the document repository located at the Geneva Free Library, 244 Main St. Geneva NY 14456. In addition, one printed copy and one electronic copy should be sent to myself as the DEC project manager. The electronic copy should also be sent to Anthony Perretta at the NYS Department of Health.

A monthly progress report will be due by the 10th of each month following this approval. Based upon the schedule in the approved Remedial Action Work Plan, field work shall begin on or before September 2017 and the next major submittal shall be the Final Engineering Report and Site Management Plan in December of 2017. Prior to the start of field work, NYSDEC will prepare a Fact Sheet to notify the public that the on-site cleanup is about to start.

As a reminder, all final documents and reports are to be in electronic format on compact computer discs (CDs). The disk should contain an Adobe® Acrobat® Portable Document Format (PDF) file and must be searchable. All data submitted to the DER must be in the DEC-approved Electronic Data Deliverable (EDD). Moreover, new data must be submitted on a continuous basis immediately after data validation occurs but in no event more than 90 days after the data have been submitted to the remedial party or its consultant(s). In other words, data are not to be held and submitted with the related reports.
