

Dear Mr. Mabry:

This letter is forwarded to your attention in response to the letter from your attorneys (Harris Beach PLLC) to the Department, dated April 21, 2010; wherein your attorneys requested, on behalf of the BCP Applicant Flexo Transparent, Inc, an Amendment of the above referenced Brownfield Cleanup Agreement entered into with the New York State Department of Environmental Conservation (the "Department"); which agreement is dated December 08, 2008, and was modified by an amendment dated March 11, 2010 to add RSB Enterprises, LLC as an additional Applicant. ("BCA" or "Agreement"). Whenever the term BCA or Agreement is used in this letter, such term shall mean the BCA signed on December 08, 2008 as amended by the March 11, 2010 amendment.

In reliance upon, and in furtherance of the letter and previous discussions, if any, of this matter between the Department's staff and the BCP applicant's representatives to date, the BCA Amendment requested is hereby granted and incorporated into and is enforceable pursuant to the subject Agreement, effective immediately upon receipt of this letter. Specifically, the property located at 1122 Seneca Street comprising approximately .39 acres is added to the agreement. The property bears the following block and lot number: Section 123, Block 29-1, Lot 12. A map reflecting the property is attached to this letter as Exhibit "A."


