Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the ENRX Annex site ("site") located at 50 Hannah Street, Buffalo, Erie County. Please see the map for the site location. Documents related to the cleanup of this site can be found at the location(s) identified to the left under "Where to Find Information."

Draft Investigation Work Plan: The draft investigation work plan, called a "Remedial Investigation Work Plan," was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by Diamond Hurwitz Scrap, LLC ("applicant") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

<u>How to Comment</u>: NYSDEC is accepting written comments about the draft investigation work plan for 30 days, from May 9 through June 9, 2018. The proposed plan is available for public review at the location(s) identified at left under "Where to Find Information." Please submit comments to the NYSDEC project manager listed under Project-Related Questions in the "Who to Contact" area at left.

<u>Highlights of the Proposed Site Investigation</u>: The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Previous investigations have detected volatile and semi-volatile organic compounds (VOCs and SVOCs) in soil and groundwater on site.

Key components of the investigation work will include:

- Installing and sampling soil borings and/or test pits to identify possible on-site sources of contamination; and
- Sampling groundwater wells to monitor impacts from areas of concern, both on-site and off-site

<u>Next Steps</u>: NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

BROWNFIELD CLEANUP PROGRAM

When the investigation is completed, a report will be prepared and submitted to the NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a cleanup plan, called a "Remedial Work Plan" will be developed and a Decision Document will be proposed. The cleanup plan will include an evaluation of the proposed site remedy, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description: The site is in an urban area in the City of Buffalo. The site consists of one (1) parcel measuring approximately 0.27 acres, with a street address of 50 Hannah Street (also known as 737 New Babcock Street).

The site is located adjacent to and south of the ENRX, Inc. - Voelker Analysis Site ("ENRX Site", #C915150) which is located at 766 New Babcock Street. The ENRX Site was issued a Certificate of Competition (COC) in December 2015 and is currently in the site management phase.

The site consists of a gravel/asphalt pavement parking lot, enclosed within fence which surrounds the adjacent BCP site C915150, as well as the vacant scrap yard, adjacent to both sites. There is fenced entrance on Hannah Street and another on New Babcock Street.

Brownfield Cleanup Program Overview: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
