Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the Lakeside Village Apartments site ("site") located at 65-67 Lake Avenue, Lancaster, Erie County. Please see the map for the site location.

Draft Investigation Work Plan: The draft investigation work plan, called a "Remedial Investigation Work Plan," (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by 65 Lake Avenue LLC ("applicant(s)") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

How to Comment: NYSDEC is accepting written comments about the Draft RIWP for 30 days, from **May 6, 2020 through June 5, 2020**.

Highlights of the Proposed Site Investigation: The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Previous investigations have detected volatile organic compounds (VOCs) in on-site soil, soil vapor, indoor air, and groundwater. Sub-slab depressurization systems, similar to radon gas mitigation systems, have been installed in two on-site buildings to mitigate indoor air impacts from contamination at the site.

Key components of the investigation work include:

- Collecting surface soil samples to characterize on-site surface conditions;
- Installing and sampling on-site soil borings to delineate sources of contamination;

- Collecting soil vapor, sub-slab soil vapor, and indoor air samples from off-site buildings (if access is granted); and
- Installing and sampling on-site groundwater wells to monitor impacts from areas of concern and determine the direction of groundwater flow.

Next Steps: NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a "Draft Remedial Work Plan" will be developed. The cleanup plan will include an evaluation of the proposed site remedy, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description: The site is 1.18-acres and is bordered to the north, west and south by either single family homes or apartment buildings, and to the east by Lake Avenue and additional residential properties. The site is currently developed with four apartment buildings, which have been in use since approximately 2006. Previously, the site has been used as a laundromat and drycleaner from approximately 1949 to 1980. Cayuga Creek is located approximately 260 feet southwest of the site.
