RE: Alaskan Oil, Incorporated Voluntary Cleanup Agreement (Index Number D7-0002-95-09) Route 342 Bioremediation Project Staged Soil Laboratory Analyses

Dear Mr. Brazell:

During the week of June 3, 1996 Alaskan Oil stripped the bioremediation cell located on Route 342 in the Town of Pamelia, New York. Approximately one-thousand two hundred (1,200) cubic yards of clean soil was removed from the cell. This soil remains staged on polyethylene sheeting to the north of the biocell. Upon completion of stripping activities, seven soil samples each consisting of seven individual grabs were collected and submitted to CES laboratory for analyses in accordance with USEPA Method 8021 and 8270 utilizing the toxicity characteristic leaching procedure. Results from laboratory analyses indicate compliance with NYSDEC STARS guidance values and are attached. On behalf of Alaskan Oil, Inc., CES requests permission to use this treated material to backfill a large excavation pit located behind the building on the Alaskan Oil property located approximately three miles away at 22947 Route 12 (Bradley Street), Watertown, New York.

As you are aware, the bioremediation cell was inoculated and tilled on June 25, 1996. Please respond in writing with approval to backfill the excavation pit with the treated material and/or contact me at (315)478-2374 to discuss the project.
