### **Agency Communications**

On January 11, 2017 H.B. Fuller was requested to provide a delivery date for the SMP. HB Fuller notified NYSDEC the report would be submitted March 31, 2017. On December 28, 2016, H.B. Fuller received a request from NYSDEC to submit the Final Engineering Report (FER) by March 31, 2017.

#### **IRM Status**

The IRM has been implemented and reported to NYSDEC October 29, 2012 in the <u>Interim Remedial</u> <u>Measures (IRM) Status Completion Report</u>. In a letter dated February 21, 2013, NYSDEC accepted this report, with comments, and no further work or revisions are expected with this task. With this task complete, the project can move to closure.

#### **Remedial Investigation Status**

The *Data Gap Remedial Investigation Report* was submitted to NYSDEC June 15, 2012. The RI was accepted, with comments by NYSDEC, February 21, 2013.

#### **Percent Completion Estimate**

The IRM has been implemented. The groundwater and sub-slab air sampling data document the IRM progressed as planned, and is 100% complete.

#### **Unresolved Delays and Mitigative Efforts**

None during the reporting period.
