On behalf of ABB, Inc. MACTEC Engineering and Consulting, Inc. (MACTEC) has prepared this letter to serve as an addendum to MACTEC's *Work Plan for Sub-Slab Vapor and Indoor Air Investigation*, dated December 23, 2009; adding three residences to the subject investigation. The request to add these residences to the investigation was made to MACTEC by Ms. Katherine Comerford of the New York State Department of Health on March 4, 2010. The other modifications contained in your letter dated January 7, 2010 will also be applied to the investigation of these additional residences.

Field activities will be scheduled contingent on the granting of access by the property owners and residential tenants but are targeted to take place on or about March 29, 30, 31.
