## NOTICE OF UPCOMING WORK AT THE CEDAR STREET FORMER MANUFACTURED GAS PLANT SITE

In Early 2003, Niagara Mohawk, A National Grid Company, (NM), will be performing remedial action activities at the former manufactured gas plant (MGP) site at 141 Cedar Street in the city of Oneida.

This remedial action involves the removal of the subsurface gas holder that remains on the site and excavation of impacted soils around the holder foundation.

All work will be completed in accordance with a Revised Remedial Design Work Plan that was developed by NM and will be approved by the New York State Department of Environmental Conservation (DEC), with the benefit of public comments received on the work plan during the comment period which closes on November 30, 2002. The Revised Remedial Design Work Plan includes a health and safety plan for the protection of worker and public health during work at the site.

## SITE HISTORY

The site consists of an approximately 0.25 acre parcel of paved, unoccupied land situated along the southeast side of Cedar Street within the City of Oneida, New York (Figure 1). The site is generally level and is supported by retaining walls of generally poor structural condition along the northeast, southeast, and southwest boundaries. The retaining walls support fill materials used to provide a level grade from Cedar Street to the southeastern site boundary. This fill material is approximately 12 feet deep at the southeastern site boundary, tapering to existing grade at Cedar Street, to the northwest. Land on the adjoining city parcels generally slopes downward from Cedar Street, to the southeast.

The site was the location for the Oneida Gas Works, which began operations at the site sometime between 1859 and 1875, until no later than 1899. At that time, it appears the location was vacated for operations at the Sconondoa Street location. The plant consisted of a coal shed, a retort building, and an octagonal gas holder. During the plant's era, the site was surrounded by a variety of industry, i.e. metal and carriage works, and was apparently elevated within retaining walls. Presumably, these are part of the existing retaining walls at the site today. Before the existence of natural gas pipelines, manufactured gas was produced at local plants by heating coal and other petroleum products in the presence of steam. The gas was used by local businesses and residents for lighting, heating, cooking and other purposes. Byproducts of the manufactured gas process and plant structures often remained at MGP sites when the plants were closed. These sites can contain coal tar, gas purifier wastes and coal ash.

A thorough investigation of the parcel and the surrounding city parcel was completed by NM. This investigation found a limited amount of contamination associated with gas manufacturing on the site. Specifically, pockets of tar and ash were observed and analytical testing of soils identified significant polyaromatic hydrocarbon (PAH) and BTEX (Benzene, Toluene, Ethylbenzene and Xylene) contaminant levels. This contamination appears to be limited to the foundations and other subsurface structures of the former plant, with the exception of a small area of contamination noted on the adjoining city parcel at boring location SB-8. This area is immediately adjacent to the site in the general area of a small watercourse that existed while the plant was operating. This contamination appears to be contained by a discontinuous, underlying peat layer.

### Proposed Remedial Design Work Plan

Based on this, a remediation work plan has been developed that will excavate the entire parcel down to unimpacted native soils. Additionally, a small volume of soil will be removed from the adjoining city parcel, in the area of soil boring SB-8. The excavation will then be backfilled to match the grade of the adjoining city parcels, with the top two feet constituting clean fill overlying a geotextile for demarcation purposes. The parcel will also be deed restricted for commercial and industrial use, as an additional precaution. The complete details of the Remedial Action are available in the Revised Remedial Design Work Plan, which is in the document repositories listed below.



Niagara Mohawk, a National Grid Company (Niagara Mohawk), in conjunction with the New York State Department of Environmental Conservation (NYSDEC) is developing plans to clean up impacted soils at a City of Oneida-owned property at 141 Cedar Street. The plans call for the removal of nearly 4,000 cubic yards of soil impacted by a former manufactured gas plant (MGP), which was operated by a Niagara Mohawk predecessor company. It is anticipated that the cleanup of the quarter-acre site will take approximately 6 to 9 months, beginning summer of 2003.

### Cleanup Components

The site cleanup will involve the excavation and offsite disposal of approximately 4,000 cubic yards of MGPimpacted soil. Most of the affected soil is within 10 feet of the existing ground surface and within the existing aboveground retaining wall structure that surrounds the property. Excavated soil will be taken offsite for treatment, consisting of low-temperature thermal desorption. This treatment will ultimately result in the

destruction of the constituents of concern and renders the soil clean. The excavated area will then be backfilled with clean materials to match the grade of the adjoining city parcels. It is expected that after the cleanup, the property will be redeveloped in connection with the City's "brownfields" program.

### Community Health and Safety

The cleanup will include measures related to community health and safety An estimated 300 to 400 one-way truck trips will be needed to remove impacted soil and replace with clean soil. During this effort, measures will be in place to limit, as well as monitor, air emissions using air monitoring stations and instrumentation. Furthermore, safety measures, such as work zones, perimeter fencing, and erosion control, will be implemented. Community health and safety will remain a priority throughout the cleanup project.



shouldn't be a total shutdown. The Sconondoa Street cleanup is much bigger. That involves 60.000 cubic yards of contaminated soil, is expected to cost \$25 million and could take up to two years!

In that project, the contantinated soil will be treated on site in a temporary thermal treatment facility set up in the Oncida Department of Public Works yard .... Niagara Mohawk originally expected to begin the project in the fall of 2001 but is now hoping to break ground next year. Stucker said the start date will be set after the city and the DEC review remedial designs.
