In accordance with your August 2, 2006 email and our discussions on September 7, 2006, FPM Group (FPM) is hereby submitting this Third Addendum to the Remedial Action Work Plan (RAWP) for the above-referenced site for your review. This Third Addendum addresses the issue of the requested additional remediation wells in the western impacted area of the site.

**Proposed Additional Western Wells**

The Volunteer has agreed to install additional remedial wells on the western side of the site to address an area of PCE-impacted groundwater near the property line, as shown on the attached Figure 4.2.2. It is intended that these western wells be used to treat the impacted groundwater that is onsite; no offsite treatment is proposed.

The proposed wells for the western system include two shallow air sparge (AS) wells, one intermediate AS well, and one deep SVE well. The locations of these proposed wells are shown on the attached figures together with the estimated radii of influence.

This western system will be installed, operated and monitored in the same manner as the system planned for the southern portion of the site, as described in the RAWP. The western system operating and monitoring data and the groundwater monitoring data will be evaluated in the same manner as for the southern system.

Please confirm that the proposed western system wells are acceptable. Please note that we are scheduled to start remediation system construction on October 16, 2006 and, therefore, a prompt response would be appreciated. Please contact me at (631) 737-6200, ext. 228 or via email on or before October 6 if you have any further comments. After October 6, please contact Ben Cancemi at my office (ext. 209).

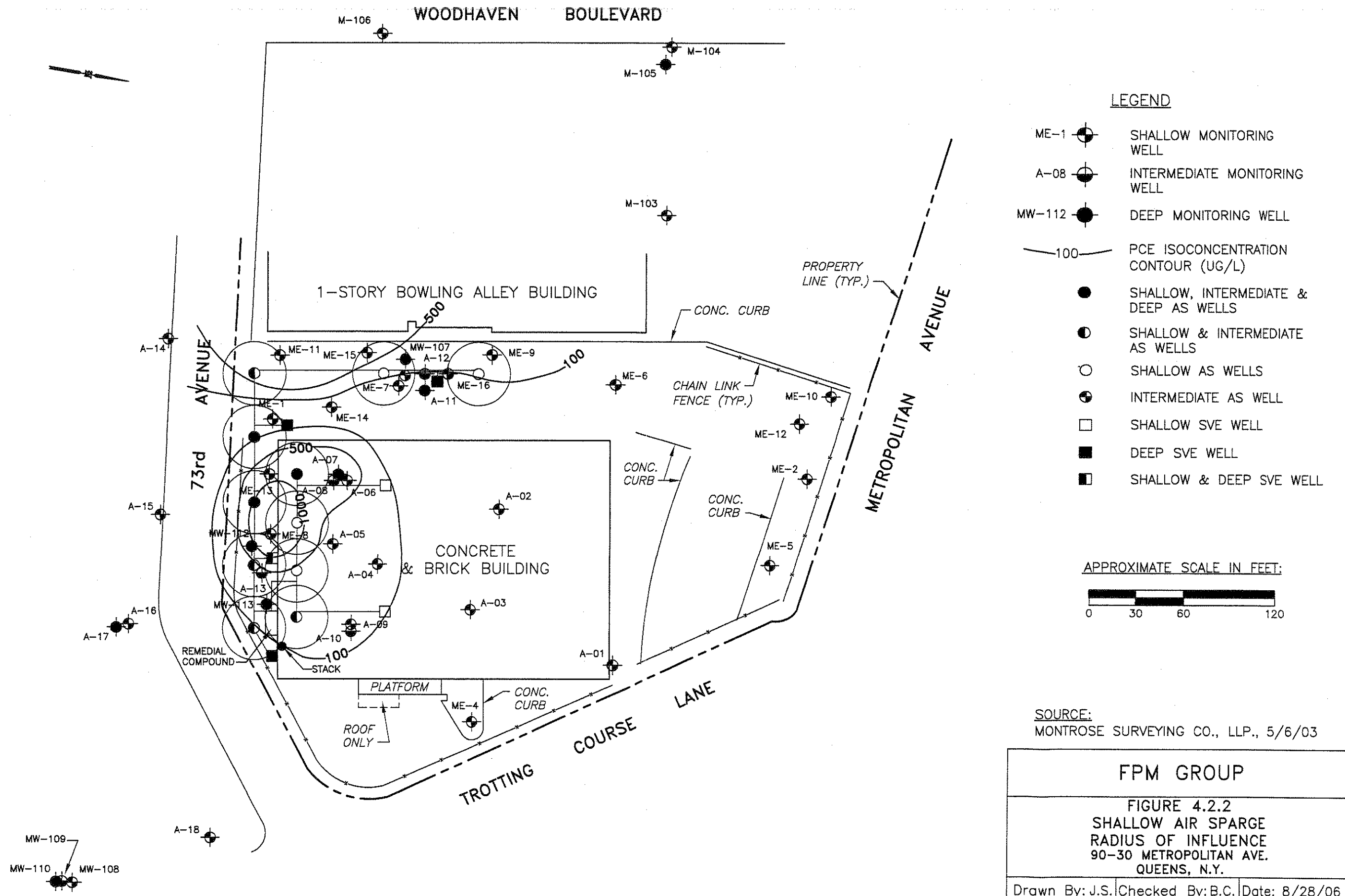

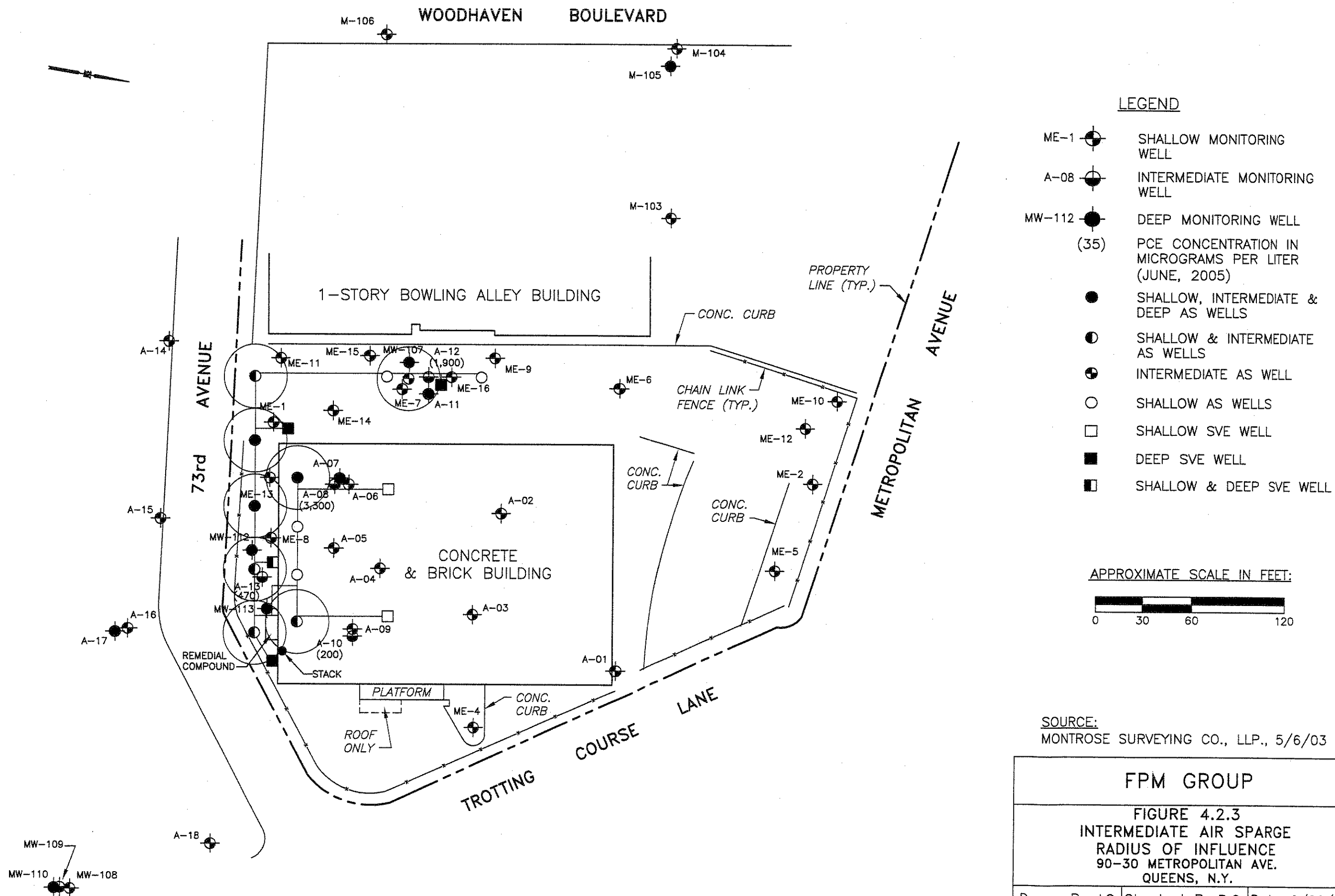
