Voluntary Site Investigation Proposed by Fyn Paint and Lacquer Co., Inc.

The subject property, a paint and lacquer factory, is located at 230 Kent Ave., Brooklyn, NY 11212, further known as "the Site". It is situated in a heavy manufacturing area of Brooklyn, approximately 500 feet east of the East River. The property is owned by the Kent River Co. and Fyn Paint and Lacquer Co., Inc. operates on the Site (its offices are located at 229 Kent Ave., Brooklyn, NY 11212).

The Site occupies a third of the square block bounded by Kent Ave., North First St., Metropolitan Ave., and River St. The building at the Site is a single story masonry structure with a partial loft. The rest of the block is occupied by a Con Edison facility. The Site's building contains a small partial basement housing an above ground oil tank and an oil burner.

Prior uses of the Site include a metal scrap yard and the manufacturing of paints and thinners for different applications. Some of the utilized chemicals, paints, thinners are stored in above ground and under ground storage tanks or in 55 gallon drums. Fenley and Nicol Environmental Inc., the former consultant company for Fyn Paint and Lacquer Co., Inc., performed a Tank Closure and identified high concentrations of thinners (Volatile Organic Compounds- VOCs) in the on site soil associated with leaking underground storage tanks. In 2002, Leggette, Brashears and Graham, Inc., (LB&G), an environmental consulting company, completed the phase I investigation. They will start the phase II investigation on the Site in January 2003.

Fyn Paint and Lacquer Co., Inc. has entered into a voluntary cleanup agreement with the New York State Department of Environmental Conservation (NYSDEC) to further investigate the vertical and horizontal extent of the contaminant plume and to address the remediation of the Site and the off-site contamination. The results of the Phase II Investigation will be reviewed by NYSDEC and NYSDOH to determine the nature and extent of the remediation that will be required to protect the environment and prevent potential public health exposure.
