## **Progress Report for June 2026**

### **LONG ISLAND RAILROAD 17 SUBSTATIONS**

**July 10, 2026**

#### **Project Activities**

- Field activities associated with the Remediation Program have been completed at the Group “C” Substation Sites (Port Washington, Hempstead, Valley Stream, Kew Gardens and Shea).
- Draft Final Engineering Reports / Site Management Plans have been submitted to the NYSDEC for the Port Washington, Hempstead and Valley Stream Substation Sites.
- The Final Engineering Reports / Site Management Plans for the Shea and Kew Gardens Substation Sites were submitted to the NYSDEC on April 19, 2018 and April 23, 2018, respectively. The NYSDEC issued release letters on July 12, 2018 for both sites.
- On July 13, 2018, the NYSDEC issued a new Order on Consent and Administrative Settlement for the Substation Sites.
- A Notice of Award was issued to the new design consultant (AECOM) on April 10, 2019 and the Notice to Proceed was issued to AECOM on June 5, 2019.
- Soil remediation activities were completed at the Group “D” Substation Sites (Bayside and Cedar Manor) on December 4, 2020 and April 14, 2021, respectively.
- On October 29, 2021, the NYSDEC issued an Amendment to the July 13, 2018 Order on Consent and Administrative Settlement for the Substation Sites by adding the Far Rockaway Substation.
- The Final Engineering Reports / Site Management Plans for the Bayside and Cedar Manor Substation Sites were submitted to the NYSDEC on September 26, 2024 for review and approval. The MTA LIRR is still awaiting comments and/or approval by the NYSDEC.
- Per the NYSDEC’s April 21, 2025 email request, a separate Monthly Progress Report has been prepared and submitted under separate cover for the Far Rockaway Substation.

#### **Deliverables**

- No deliverables were submitted in the month of June 2026.

#### **Planned July 2026 Activities**

- Resubmit the Final Engineering Reports / Site Management Plans to the NYSDEC for the Group “B” Substation Sites (Floral Park and Mineola) and the Group “C” Substation Sites (Hempstead, Port Washington and Valley Stream), in addition to Rockville Centre, following the filing of the Declaration of Covenants and Restrictions.
