# Interim Remedial Measure Cleanup Action to Begin at Voluntary Cleanup Program Site

A cleanup action, called an interim remedial measure, is about to begin that will address contamination related to the Safeguard Storage Baldwin Site ("site"), located at 1170 Atlantic Avenue in Baldwin, Town of Hempstead and Nassau County under New York's Voluntary Cleanup Program. See map for site location.

The cleanup action for the site includes: excavating contaminated soils and chemical treatment of the impacted groundwater. The cleanup activities will be performed by Safeguard Self Storage ("volunteer"). The New York State Department of Environmental Conservation (NYSDEC) and the New York State Department of Health (NYSDOH) will provide oversight.

#### Highlights of the Upcoming Cleanup Activities

The goal of the Interim Remedial Measure (IRM) is to reduce site contamination prior to the final remedial action which will ultimately clean up the site to a level that protects both public health and the environment for the site's proposed use.

The IRM work will consist of the excavation of volatile organic compound (VOC) impacted

**Voluntary Cleanup Program:** New York's Voluntary Cleanup Program (VCP) was developed to encourage private sector volunteers to investigate and clean up contaminated properties and return these sites to productive use. Once cleaned up, the properties may be redeveloped for commercial, industrial, residential or public use.

For more information about the VCP, visit: www.dec.ny.gov/chemical/8442.html soils surrounding a contaminated drywell and enhanced bioremediation of impacted groundwater. After the excavation of the contaminated soil, enhanced bioremediation will be achieved by placing chemical treatments into the now open drywell excavation. The excavation will then be filled with clean fill.

The chemicals of concern are VOCs, chlorinated solvents resulting from prior site usage during lighting equipment manufacturing. Chlorinated solvents were used to clean metal parts prior to painting. The solvent contamination is located near an existing drywell on the east side of the building; it consists of trichloroethane and its breakdown products dichloroethane and chloroethane. These chemicals have contaminated the on-site soils and groundwater adjacent to the impacted drywell.

The excavation of approximately 60 tons of contaminated soil will coincide with the planned bulkhead replacement on the site. The contaminated soil will be excavated, stockpiled, segregated, tested and trucked off-site for proper disposal. Prior to backfilling the excavation, Hydrogen Release Compound (HRC), the chemical treatment, will be distributed into the excavation at low tide. The HRC will enhance the current biological conditions and allow the naturally occurring bacteria to degrade the VOCs in groundwater.

#### **Next Steps**

The volunteer is expected to begin cleanup activities at the site during September 2011. The excavation and removal of contaminated soil, and chemical treatment is anticipated to take about two weeks. Other work at the property, including the bulkhead replacement, will start prior to the contaminated soil removal and will last longer.

After the volunteer completes the IRM cleanup activities, they will summarize the work and sampling data in an IRM Engineering Report and submit it to NYSDEC.

#### Background

NYSDEC previously accepted an application from the volunteer to participate in the Voluntary Cleanup Program. The application proposes that the site will be used for restricted industrial purposes.

The 2.7 acre site is located on a built-up island in Milburn Creek and is situated south of Atlantic Avenue. The site is presently occupied by Safeguard Storage. Past site use has included an indoor tennis facility, Lightalarms Electronics Corporation (emergency lighting manufacture), and a boat storage and repair yard.


