
VOLUNTARY CLEANUP AGREEMENT

Site No. V00691-3 March 2006

INTRODUCTION

The New York State Department of Environmental Conservation (NYSDEC), in cooperation with the New York State Department of Health (NYSDOH), is pleased to inform you that Stewart EFI, New York, LLC has volunteered to investigate and remediate contamination (if found) at their facility located at 630 Central Park Avenue in Yonkers, New York (see figure below).

The investigation activities, to be performed under the NYSDEC's Voluntary Cleanup Program, include soil, groundwater and sub-slab soil gas sampling. These activities will determine the nature and extent of any contamination in the site soils, groundwater, and sub-slab soil gas, as well as identify potential off-site impacts.

BACKGROUND

The facility currently manufactures metal parts for the automotive and electronics components industries via several high-speed stamping processes. There are several finishing processes including plating, polishing, and heat treatment performed at the facility. Stewart Stamping, the former owners, also manufactured and finished metal parts at this facility since 1942. Historically, the plating room has been used for metal parts finishing throughout most of the facility's operational history, and may be a potential source for release of plating chemicals. Historic degreasing operations are also a concern. Chlorinated solvents including methylene chloride, tetrachloroethene, trichloroethene and 1,1,1-trichloroethane are used for parts cleaning at the facility. In 1996, four underground # 4 fuel oil tanks were emptied and closed in place at the facility, after pressure tests indicated the tanks were "tight."

Previous limited site investigation activities indicated the presence of metals, polyaromatic hydrocarbons (PAHs), and volatile organic compounds (VOCs) in site soils; however, only one PAH (benzo(a)pyrene) and two metals (zinc and chromium) marginally exceeded NYSDEC's recommended soil cleanup objectives. In groundwater, a few VOCs were detected, but none exceeded the NYS groundwater standards. Two metals, arsenic and chromium, marginally exceeded the NYS groundwater standards, and zinc was detected well above the NYS groundwater standard.

COMPONENTS OF INVESTIGATION

Based on the previous site investigations, Stewart EFI will further investigate the site soils, groundwater and soil gas to determine the nature and extent of potential contamination on-site and the potential for any off-site impacts. If necessary, based on the results of the additional investigation activities, the Volunteer will submit a Remediation Work Plan to the NYSDEC and NYSDOH to outline the remedial activities to be performed.
