Description:

NYC-HH - CUMBERLAND TREATMENT & DIAGNOSTIC CENTER (CDTC) is a medical facility located at 100 N Portland Ave, Brooklyn, New York.

CDTC is currently permitted as a State Facility Permit to operate three (3) 11.20 mmBtu/hr identical boilers firing #6 fuel oil only, one (1) emergency diesel generator and three (3) underground fuel oil storage tanks.

CDTC is replacing the three existing boilers with two (2) 10.46 mmBtu/hr new identical Cleaver Brooks CBI-200-250-125 dual fuel boilers firing natural gas or #2 fuel oil. The #6 oil tank will be converted to #2 oil tank. In addition, CDTC operates two (2) identical exempt size 1.999 mmBtu/hr Raypak/WH7-2003 gas only firing domestic hot water heaters and one (1) domestic water boiler rated at 2.501 mmBtu/hr Raypak/H7-2503 also firing on gas only.

The annual facility nitrogen oxides (NOx) emissions are limited to 24.9 tons per year.



Records demonstrating compliance with this cap will be kept in accordance with the permit specific conditions.

The facility is subject to the provisions of State Facility requirements specified under 6NYCRR 201-7.

The Air State Facility permit contains a listing of the applicable federal, state, and compliance monitoring requirements for the facility.

Item B: Acceptable Ambient Air Quality - 6 NYCRR 200.6

Notwithstanding the provisions of 6 NYCRR Chapter III, Subchapter A, no person shall allow or permit any air contamination source to emit air contaminants in quantities which alone or in combination with emissions from other air contamination sources would contravene any applicable ambient air quality standard and/or cause air pollution. In such cases where contravention occurs or may occur, the Commissioner shall specify the degree and/or method of emission control required.

Item C: Maintenance of Equipment - 6 NYCRR 200.7

- (2) The equipment at the permitted facility causing the emergency was at the time being properly operated and maintained;
- (3) During the period of the emergency the facility owner or operator took all reasonable steps to minimize levels of emissions that exceeded the emission standards, or other requirements in the permit; and
- (4) The facility owner or operator notified the Department within two working days after the event occurred. This notice must contain a description of the emergency, any steps taken to mitigate emissions, and corrective actions taken.
- (b) In any enforcement proceeding, the facility owner or operator seeking to establish the occurrence of an emergency has the burden of proof.
- (c) This provision is in addition to any emergency or upset provision contained in any applicable requirement.
