#### PERMIT DESCRIPTION

This is a new Air State Facility (ASF) permit for the existing Title V facility in compliance with 6 NYCRR 201 - Permits and Regulations. The current Title V permit (Renewal #2) for Franklin Plaza Apartments is expiring on 11/15/2017. This facility is downgrading the current Title V permit status to an Air State Facility (ASF) Permit by capping the facility-wide total NOx emissions to 24.9 tons per year, below Title V thresholds of 25 tpy.

Franklin Plaza Apartments is a high-rise housing complex consisting of apartments and residences with a central heating plant to provide heat and hot water to the residential units. Franklin Plaza Apartments in New York City, New York, provides steam heat, and hot water for 1,635 residential apartments in the apartment housing complex. The steam and the hot water is provided using seven (7) boilers primarily burning natural gas (Process GAS) and low-sulfur #2 distillate fuel oil (Process OIL) during gas curtailment periods to provide heat and hot water to the residences in multiple buildings. The emissions are exhausted through two stacks which are identified as Emission Points 00005 & 00006. Emission Sources 00001, 00002, 00003, 00004, 00005 & 00006 were constructed on 4/1/1950 and Emission Source 00007 was constructed on 4/1/1981. Each of these seven



boilers has a heat input of 14.65 MM Btu/hr, and each of these seven (7) boilers incorporate Webster (HDRV5C) burners. The Industrial Classification Code (SIC) for this facility is 6513 - Apartment Building Operators.

The seven low pressure boilers make & model in Emission Unit U-C0001 which supply both hot water and steam for the space heating of the building are as follow:

Emission Sources 00001 &00003 are Fitzgibbons DS425,

Emission Source 00002 is an Eastmond FST-400,

Emission Source 00004 is a Federal FST-350, and

Emission Sources 00005, 00006 & 00007 are an Easco SMU-500-5015.

These seven boilers provide heat & domestic hot water to residential dwellings. The facility has submitted the fuel consumption for the period of 1/1/2016 thru 12/31/2016 as 92,840 gallons of #6 fuel oil and 75,839,500 cubic feet of natural gas.

The Air State Facility permit contains a complete listing of the applicable federal, state and compliance monitoring requirements for the facility, its emission unit and emission point.

Franklin Plaza Apartments is subject to the provisions of the Air State Facility permits as per 6 NYCRR 201-5, sulfur dioxide as per 6 NYCRR 225-1, fuel composition, sampling, analysis and use - sulfur limitations, which restricts the sulfur content of the #2 distillate fuel oil utilized throughout the facility to 0.0015 % by weight or less. Emission Point C0001 is subject to the smoke emission of 6 NYCRR 227-1.3, the corrective action requirements of 6 NYCRR 227-1.6 and to the particulate emission limit of 0.10 lbs/MM Btus as per 6 NYCRR 227-2(b)(1) for stationary combustion installations. The facility is also subject to 6 NYCRR 227-2.4, reasonably available control technology (RACT) for oxides of nitrogen for small boilers by performing annual tune-ups to each of the boilers and complying with the specified reporting and record keeping requirements.

The facility operates other sources which are considered exempt from permitting in accordance with 6 NYCRR 201-3.2(c), including two (2) horizontal petroleum storage tanks (30,000 gallons each) and six-eight (68) laundry dryers.

Unless authorized by the Commissioner, no person shall remove or alter any seal affixed to any contamination source in accordance with this section.

#### Item B: Acceptable Ambient Air Quality - 6 NYCRR 200.6

Notwithstanding the provisions of 6 NYCRR Chapter III, Subchapter A, no person shall allow or permit any air contamination source to emit air contaminants in quantities which alone or in combination with emissions from other air contamination sources would contravene any applicable ambient air quality standard and/or cause air pollution. #### Item 2.1:

#### Item 2.2

Per Section 215.3, burning in an open fire, provided it is not contrary to other law or regulation, will be allowed as follows:

- (a) On-site burning in any town with a total population less than 20,000 of downed limbs and branches (including branches with attached leaves or needles) less than six inches in diameter and eight feet in length between May 15th and the following March 15th. For the purposes of this subdivision, the total population of a town shall include the population of any village or portion thereof located within the town. However, this subdivision shall not be construed to allow burning within any village.
- (b) Barbecue grills, maple sugar arches and similar outdoor cooking devices when actually used for cooking or processing food.
- (c) Small fires used for cooking and camp fires provided that only charcoal or untreated wood is used as fuel and the fire is not left unattended until extinguished.
- (d) On-site burning of agricultural wastes as part of a valid agricultural operation on contiguous

agricultural lands larger than five acres actively devoted to agricultural or horticultural use, provided such waste is actually grown or generated on those lands and such waste is capable of being fully burned within a 24-hour period.

- (e) The use of liquid petroleum fueled smudge pots to prevent frost damage to crops.
- (f) Ceremonial or celebratory bonfires where not otherwise prohibited by law, provided that only untreated wood or other agricultural products are used as fuel and the fire is not left unattended until extinguished.
- (g) Small fires that are used to dispose of a flag or religious item, and small fires or other smoke producing process where not otherwise prohibited by law that are used in connection with a religious ceremony.
- (h) Burning on an emergency basis of explosive or other dangerous or contraband materials by police or other public safety organization.
- (i) Prescribed burns performed according to Part 194 of this Title.
- (j) Fire training, including firefighting, fire rescue, and fire/arson investigation training, performed under applicable rules and guidelines of the New York State Department of State's Office of Fire Prevention and Control. For fire training performed on acquired structures, the structures must be emptied and stripped of any material that is toxic, hazardous or likely to emit toxic smoke (such as asbestos, asphalt shingles and vinyl siding or other vinyl products) prior to burning and must be at least 300 feet from other occupied structures. No more than one structure per lot or within a 300 foot radius (whichever is bigger) may be burned in a training exercise.
- (k) Individual open fires as approved by the Director of the Division of Air Resources as may be required in response to an outbreak of a plant or animal disease upon request by the commissioner of the Department of Agriculture and Markets, or for the destruction of invasive plant and insect species.
- (l) Individual open fires that are otherwise authorized under the environmental conservation law, or by rule or regulation of the Department.

- (1) An emergency occurred and that the facility owner or operator can identify the cause(s) of the emergency;
- (2) The equipment at the permitted facility causing the emergency was at the time being properly operated and maintained;
- (3) During the period of the emergency the facility owner or operator took all reasonable steps to minimize levels of emissions that exceeded the emission standards, or other requirements in the permit; and
- (4) The facility owner or operator notified the Department within two working days after the event occurred. This notice must contain a description of the emergency, any steps taken to mitigate emissions, and corrective actions taken.
- (b) In any enforcement proceeding, the facility owner or operator seeking to establish the occurrence of an emergency has the burden of proof.
- (c) This provision is in addition to any emergency or upset provision contained in any applicable requirement.

## Item B: Public Access to Recordkeeping for Facilities With State Facility Permits - 6 NYCRR 201-1.10 (a)
