Description:

Rockland Psychiatric Center is a State-owned hospital serving Rockland, Westchester, Orange, Sullivan, Putnam, Dutchess and Ulster counties. A new centralized utility plant (CUP) will provide steam for the heating and cooling of eleven of the scores of buildings formerly heated by the old plant. Numerous buildings on the campus have been vacated, sold or leased to other entities or are slated to be demolished. The CUP will therefore serve a much smaller consolidated campus.

This project comprises the construction of a new centralized utility plant (CUP) to replace an existing Title V facility. The new CUP building will house three boilers, each with a maximum heat capacity of 24.9 mmBtu/hr. These boilers are designed to combust natural gas and No. 2 fuel oil to produce steam for space heating and cooling. Combustion of No. 6 fuel oil will cease with the decommissioning of the existing Title V plant. The CUP will also house two new, diesel-powered generators rated at 100 kW and 2000 kW at maximum output. A third new 2000 kW unit will be constructed in a shed near Building 39. The new generators are additional to the eight exempt generators located on-site, some of which are slated to be decommissioned in the near future. Facility is capped below 25 tons per year of NOx. As a minor source, the facility is not subject to the Title V permitting requirements of 6 NYCRR Part 201-6.



The facility is subject to monitoring, reporting and recordkeeping requirements under 6 NYCRR Part 201, 6 NYCRR Part 225 and 6 NYCRR Part 227. The facility is also subject to 40 CFR 60 Subpart IIII and 40 CFR 63 Subpart JJJJJJ federal requirements. Air state facility permits expire after ten years, as per 6 NYCRR Part 201-5.2(c). The Standard Industrial Classification representative of this facility is 8063 – Psychiatric Hospitals.

No person shall operate any air contamination source sealed by the Commissioner in accordance with this section unless a modification has been made which enables such source to comply with all requirements applicable to such modification.

Unless authorized by the Commissioner, no person shall remove or alter any seal affixed to any contamination source in accordance with this section.

Item B: Acceptable Ambient Air Quality - 6 NYCRR 200.6

Notwithstanding the provisions of 6 NYCRR Chapter III, Subchapter A, no person shall allow or permit any air contamination source to emit air contaminants in quantities which alone or in combination with emissions from other air contamination sources would contravene any applicable ambient air quality standard and/or cause air pollution. In such cases where contravention occurs or may occur, the Commissioner shall specify the degree and/or method of emission control required.

Item C: Maintenance of Equipment - 6 NYCRR 200.7

Any person who owns or operates an air contamination source which is equipped with an emission control device shall operate such device and keep it in a satisfactory state of maintenance and repair in accordance with ordinary and necessary practices, standards and procedures, inclusive of manufacturer's specifications,



required to operate such device effectively.

Item D: Unpermitted Emission Sources - 6 NYCRR 201-1.2
