Description:

This Air State Facility Permit modification adds an emission unit at the facility; a Crawford C1000P Multiple Chambered Cremation/Incinerator (Emission Unit 0-00002). An existing emission unit, Emission Unit 0-00003 is a Facultatieve Technologies ISI 60 Animal Cremator multiple chambered, excess air, natural gas fired cremator. The modification also updates the permit to reflect the revised 6 NYCRR Part 219-4 Incinerators, Crematories rule, which went into effect on March 14, 2020. One of the things that the recently adopted 6 NYCRR Part 219-4 Incinerators, Crematories rule did was to lower the allowed minimum temperature in the secondary chamber (afterburner) from 1800 degrees Fahrenheit to 1600 degrees Fahrenheit. Emission Unit 000002 and Emission Unit 0-00003 are subject to the requirements of 6NYCRR Part 219 Subpart 4: Incinerators, Crematories, which includes a limit on particulate emissions and an opacity limit; design and operating requirements that mandate the owner or operator of a cremation unit must maintain a one-hour average temperature of at least 1600 degrees Fahrenheit in the secondary combustion chamber, with a minimum residence time for combustion gases of at least one second, at all times remains are being cremated; continuous monitoring of the temperature in the secondary chamber; operator training and certification; monitoring and recordkeeping; preventative/routine maintenance and an annual inspection by a qualified service technician.

Emission Unit 0-00002 consists of one multiple chambered, excess air, random load incinerator, manufactured by Crawford Industrial Group, LLC (formerly Crawford Equipment



& Engineering Company), used for the cremation of small animals collected from local veterinarians, small animal hospitals and other sources. The Crawford Model C-1000P incinerator, identified as Emission Source 00002 (primary chamber) and Emission Source Control C0002 (secondary chamber), has a maximum allowable charge rate of 600 lbs and a maximum allowable burn rate of 175 lb/hr. The random load feature allows for the insertion of additional carcasses during the burn cycle. The primary chamber has one, hi/lo modulated, 500,000 BTU/hr gas-fired burner and the secondary chamber has one, fully modulated 1,500,000 BTU/hr gas-fired burner. Residence time is greater than one second in the secondary chamber. The temperature of the secondary chamber is continuously monitored and recorded via a Danaher MRC 5000 digital circle chart recorder. Emissions from the primary chamber are controlled via combustion in the secondary chamber. An electronic gas scanner with control to the primary chamber is located in the hot air duct of the incinerator to control opacity to less than 10%. Emissions from ES Control C0002 are exhausted to the ambient air through Emission Point 00002. A stack test for particulates from Emission Unit 0-00002 was performed on August 28, 2008. The reported stack test results showed an average emission rate of particulates at 0.03 gr/dscf corrected to seven percent oxygen. 6 NYCRR Part 219-4.3(a) states no person may cause or allow emissions of particulates into the outdoor atmosphere from an existing cremation unit in excess of 0.08 grains per dry standard cubic foot of flue gas, corrected to seven percent oxygen. Based on the stack test results, the report was approved and thus 6 NYCRR Part 219-4.5(a) has been completed.

Emission Unit 0-00003 consists of one Facultatieve Technologies ISI 60 Animal Cremator multiple chambered, excess air, natural gas fired cremator. The cremator is used for the cremation of small animals collected from local veterinarians, small animal hospitals and other offsite sources, which is identified as Process 003. The animal carcasses are combusted in the primary chamber, which is identified as Emission Source 00003 in this permit. Emissions from the primary chamber are controlled via combustion in the secondary chamber, identified as Emission Source Control 0003. The cremator has a nominal burn rate of 140 lbs per hour with a maximum batch size of 700 lbs of animal cadavers. The cremator is designed for manual single batch loading. Its automatic controls will function to cremate efficiently with the minimum of operator intervention. Once the secondary chamber reaches 1600 degrees Fahrenheit, the operator will open the door of the primary chamber via automated controls, charge the animal cadaver and then close the door of the primary chamber. All functions of the loading process are controlled by the onboard computer/PLC controller. The cremator has a sight glass where the operator can observe the cremation process and thus determine when the complete cremation process has been fully completed. The secondary chamber of the cremator is equipped with one 1,200,000 BTU/hr gas fired burner. The gross gas input for the complete unit (covers both primary chamber burner and secondary chamber burner) is 2,100,000 BTU/hr. The secondary chamber of the cremator has a residence time of greater than one second. When the cremator is operating, the temperature of the primary chamber and the secondary chamber are controlled by the use of a temperature probe and PLC logic. Emissions from ES 00003 are exhausted to the ambient air through Emission Point 00003. A stack test for particulates from Emission Unit 0-00003 was performed on October 22, 2020. The reported stack test results showed an average emission rate of particulates at 0.05 gr/dscf corrected to seven percent oxygen. 6 NYCRR Part 219-4.3(a) states no person may cause or allow emissions of particulates into the outdoor atmosphere from an existing cremation unit in excess of 0.08 grains per dry standard cubic foot of flue gas, corrected to seven percent oxygen. Based on the stack test results, the report was approved and thus 6 NYCRR Part 219-4.5(a) has been completed.

Condition 1: Facility Inspection by the Department
Applicable State Requirement: ECL 19-0305

Item 1.1:

The permitted site or facility, including relevant records, is subject to inspection at reasonable hours and intervals by an authorized representative of the Department of Environmental Conservation (the Department) to determine whether the permittee is complying with this permit and the ECL. Such representative may order the work suspended pursuant to ECL 71-0301 and SAPA 401(3).

Item 1.2:

The permittee shall provide a person to accompany the Department's representative during an inspection to the permit area when requested by the Department.

Item 1.3:

A copy of this permit, including all referenced maps, drawings and special conditions, must be available for inspection by the Department at all times at the project site or facility. Failure to produce a copy of the permit upon request by a Department representative is a violation of this permit.

Condition 2: Relationship of this Permit to Other Department Orders and Determinations Applicable State Requirement: ECL 3-0301 (2) (m)

Item 2.1:

Unless expressly provided for by the Department, issuance of this permit does not modify, supersede or rescind any order or determination previously issued by the Department or any of the terms, conditions or requirements contained in such order or determination.

Condition 3: Applications for permit renewals, modifications and transfers Applicable State Requirement: 6 NYCRR 621.11

Item 3.1:

The permittee must submit a separate written application to the Department for renewal, modification or transfer of this permit. Such application must include any forms or supplemental information the Department requires. Any renewal, modification or transfer granted by the Department must be in writing.

Item3.2:

The permittee must submit a renewal application at least 180 days before the expiration of permits for Title V and State Facility Permits.

Item 3.3

NOTIFICATION OF GENERAL PERMITTEE OBLIGATIONS

This section contains terms and conditions which are federally enforceable. Permittees may also have other obligations under regulations of general applicability

Item A: Sealing - 6 NYCRR 200.5

The Commissioner may seal an air contamination source to prevent its operation if compliance with 6 NYCRR Chapter III is not met within the time provided by an order of the Commissioner issued in the case of the violation. Sealing means labeling or tagging a source to notify any person that operation of the source is prohibited, and also includes physical means of preventing the operation of an air contamination source without resulting in destruction of any equipment associated with such source, and includes, but is not limited to, bolting, chaining or wiring shut control panels, apertures or conduits associated with such source.

No person shall operate any air contamination source sealed by the Commissioner in accordance with this section unless a modification has been made which enables such source to comply with all requirements applicable to such modification.

Unless authorized by the Commissioner, no person shall remove or alter any seal affixed to any contamination source in accordance with this section.

Item B: Acceptable Ambient Air Quality - 6 NYCRR 200.6

Notwithstanding the provisions of 6 NYCRR Chapter III, Subchapter A, no person shall allow or permit any air contamination source to emit air contaminants in quantities which alone or in combination with emissions from other air contamination sources would contravene any applicable ambient air quality standard and/or cause air pollution. In such cases where contravention occurs or may occur, the Commissioner shall specify the degree and/or method of emission control required.

Item C: Maintenance of Equipment - 6 NYCRR 200.7

Any person who owns or operates an air contamination source which is equipped with an emission control device shall operate such device and keep it in a satisfactory state of maintenance and repair in accordance with ordinary and necessary practices, standards and



procedures, inclusive of manufacturer's specifications, required to operate such device effectively.

Item D: Unpermitted Emission Sources - 6 NYCRR 201-1.2

- (a) Except as otherwise provided by this Part, construction or operation of a new, modified or existing air contamination source without a registration or permit issued pursuant to this Part is prohibited.
- (b) If an existing facility or emission source was subject to the permitting requirements of this Part at the time of construction or modification, and the owner or operator failed to apply for a permit or registration as described in this Part, the owner or operator must apply for a permit or registration in accordance with the provisions of this Part. The facility or emission source is subject to all regulations that were applicable to it at the time of construction or modification and any subsequent requirements applicable to existing emission sources.

Item E: Recycling and Salvage - 6 NYCRR 201-1.7

Where practical, any person who owns or operates an air contamination source shall recycle or salvage air contaminants collected in an air cleaning device according to the requirements of 6 NYCRR.

Item F: Prohibition of Reintroduction of Collected Contaminants to the Air - 6 NYCRR 201-1.8

No person shall unnecessarily remove, handle, or cause to be handled, collected air contaminants from an air cleaning device for recycling, salvage or disposal in a manner that would reintroduce them to the outdoor atmosphere.

Item G: Proof of Eligibility for Sources Defined as Exempt Activities - 6 NYCRR 201-3.2 (a)

The owner and/or operator of an emission source or unit that is eligible to be exempt, may be required to certify that it operates within the specific criteria described in 6 NYCRR Subpart 201-3. The owner or operator of any such emission source must maintain all required records on-site for a period of five years and make them available to representatives of the Department upon request. Department representatives must be granted access to any facility which contains emission sources or units subject to 6 NYCRR Subpart 201-3, during normal operating hours, for the purpose of determining compliance with this and any other state and federal air pollution control requirements, regulations, or law.



Item H: Proof of Eligibility for Sources Defined as Trivial Activities - 6 NYCRR 201-3.3 (a)

The owner and/or operator of an emission source or unit that is listed as being trivial in 6 NYCRR Part 201 may be required to certify that it operates within the specific criteria described in 6 NYCRR Subpart 201-3. The owner or operator of any such emission source must maintain all required records on-site for a period of five years and make them available to representatives of the Department upon request. Department representatives must be granted access to any facility which contains emission sources or units subject to 6 NYCRR Subpart 201-3, during normal operating hours, for the purpose of determining compliance with this and any other state and federal air pollution control requirements, regulations, or law.

Item I: Required Emission Tests - 6 NYCRR 202-1.1

An acceptable report of measured emissions shall be submitted, as may be required by the Commissioner, to ascertain compliance or noncompliance with any air pollution code, rule, or regulation. Failure to submit a report acceptable to the Commissioner within the time stated shall be sufficient reason for the Commissioner to suspend or deny an operating permit. Notification and acceptable procedures are specified in 6 NYCRR Subpart 202-1.

Item J: Open Fires Prohibitions - 6 NYCRR 215.2

Except as allowed by section 215.3 of 6 NYCRR Part 215, no person shall burn, cause, suffer, allow or permit the burning of any materials in an open fire.

Item K: Permit Exclusion - ECL 19-0305

The issuance of this permit by the Department and the receipt thereof by the Applicant does not and shall not be construed as barring, diminishing, adjudicating or in any way affecting any legal, administrative or equitable rights or claims, actions, suits, causes of action or demands whatsoever that the Department may have against the Applicant for violations based on facts and circumstances alleged to have occurred or existed prior to the effective date of this permit, including, but not limited to, any enforcement action authorized pursuant to the provisions of applicable federal law, the Environmental Conservation Law of the State of New York (ECL) and Chapter III of the Official Compilation of the Codes, Rules and Regulations of the State of New York (NYCRR). The issuance of this permit also shall not in any way affect pending or future enforcement actions under the

Clean Air Act brought by the United States or any person.

Item L: Federally Enforceable Requirements - 40 CFR 70.6 (b)

All terms and conditions in this permit required by the Act or any applicable requirement, including any provisions designed to limit a facility's potential to emit, are enforceable by the Administrator and citizens under the Act. The Department has, in this permit, specifically designated any terms and conditions that are not required under the Act or under any of its applicable requirements as being enforceable under only state regulations.

FEDERAL APPLICABLE REQUIREMENTS The following conditions are federally enforceable.

Condition 1: Visible Emissions Limited

Effective between the dates of 01/16/2020 and 01/15/2030

Applicable Federal Requirement: 6 NYCRR 211.2

Item 1.1:

Except as permitted by a specific part of this Subchapter and for open fires for which a restricted burning permit has been issued, no person shall cause or allow any air contamination source to emit any material having an opacity equal to or greater than 20 percent (six minute average) except for one continuous six-minute period per hour of not more than 57 percent opacity.

NOTIFICATION OF GENERAL PERMITTEE OBLIGATIONS

Item A: Emergency Defense - 6 NYCRR 201-1.5

An emergency, as defined in 6 NYCRR subpart 201-2, constitutes an affirmative defense to penalties sought in an enforcement action brought by the department for noncompliance with emissions limitations or permit conditions for all facilities in New York State.

- (a) The affirmative defense of emergency shall demonstrate, through properly signed, contemporaneous operating logs, or other relevant evidence that:
- (1) an emergency occurred and that the facility owner or operator can identify the cause(s) of the emergency;
- (2) the equipment at the facility was being properly operated and maintained:
- (3) during the period of the emergency the facility owner or operator took all reasonable steps to minimize the levels of emissions that exceeded the emission standards, or other requirements in the permit; and
- (4) the facility owner or operator notified the department within two working days after the event occurred. This notice must contain a description of the emergency, any steps taken to mitigate emissions, and any corrective actions taken.
- (b) In any enforcement proceeding, the facility owner or operator seeking to establish the occurrence of an emergency has the burden of proof.
- (c) This provision is in addition to any emergency or malfunction provision contained in any applicable requirement.

Item B: Public Access to Recordkeeping for Facilities With State Facility Permits - 6 NYCRR 201-1.10 (a)

Where facility owners and/or operators keep records pursuant to compliance with the requirements of 6 NYCRR Subpart 201-5.4, and/or the emission capping requirements of 6 NYCRR Subpart 201-7, the Department will make such



records available to the public upon request in accordance with 6 NYCRR Part 616 - Public Access to Records. Facility owners and/or operators must submit the records required to comply with the request within sixty working days of written notification by the Department.

Item C: General Provisions for State Enforceable Permit Terms and Condition - 6 NYCRR Part 201-5

Any person who owns and/or operates stationary sources shall operate and maintain all emission units and any required emission control devices in compliance with all applicable Parts of this Chapter and existing laws, and shall operate the facility in accordance with all criteria, emission limits, terms, conditions, and standards in this permit. Failure of such person to properly operate and maintain the effectiveness of such emission units and emission control devices may be sufficient reason for the Department to revoke or deny a permit.

The owner or operator of the permitted facility must maintain all required records on-site for a period of five years and make them available to representatives of the Department upon request. Department representatives must be granted access to any facility regulated by this Subpart, during normal operating hours, for the purpose of determining compliance with this and any other state and federal air pollution control requirements, regulations or law.

Item 1-1.1:

- (a) The facility owner or operator shall take all necessary and appropriate actions to prevent the emission of air pollutants that result in contravention of any applicable emission standard during periods of start-up, shutdown, or malfunction.
- (b) The facility owner or operator shall compile and maintain records of all equipment maintenance and start-up/shutdown activities when they are expected to result in an exceedance of any applicable emission standard, and shall submit a report of such activities to the department when required by a permit condition or upon request by the department. Such reports shall state whether an exceedence occurred and if it was unavoidable, include the time, frequency and duration of the exceedence, and an estimate of the emission rates of any air contaminants released. Such records shall be maintained for a period of at least five years and made available for review to department representatives upon request. Facility owners or operators subject to continuous monitoring and quarterly reporting requirements need not submit additional reports of exceedences to the department.
- (c) In the event that air contaminant emissions exceed any applicable emission standard due to a malfunction, the facility owner or operator shall notify the department as soon as possible during normal working hours, but not later than two working days after becoming aware that the malfunction occurred. In addition, the facility owner or operator shall compile and maintain a record of all malfunctions. Such records shall be maintained at the facility for a period of at least five years and must be made available to the department upon request. When requested by the department, the facility owner or operator shall submit a written report to the department describing the malfunction, the corrective action taken, the air contaminants emitted, and the resulting emission rates and/or opacity.
- (d) The department may also require the facility owner or operator to include, in reports described under Subdivisions (b) and (c) of this Section, an estimate of the maximum ground level concentration of each air contaminant emitted and the effect of such emissions.
- (e) A violation of any applicable emission standard resulting from start-up, shutdown, or malfunction conditions at a permitted or registered facility may not be subject to an enforcement action by the department and/or penalty if the department determines, in its sole discretion, that such a violation was unavoidable. The random load feature allows for the insertion of additional carcasses during the burn cycle. The primary chamber has one, hi/lo modulated, 500,000 BTU/hr gas-fired burner and the secondary chamber has one, fully modulated 1,500,000 BTU/hr gas-fired burner. Residence time is greater than one second in the secondary chamber. The temperature of the secondary chamber is continuously monitored and recorded via a Danaher MRC 5000 digital circle chart recorder. Emissions from the primary chamber are controlled via combustion in the secondary chamber. An electronic gas scanner with control to the primary chamber is located in the hot air duct of the incinerator to control opacity to less than 10%. Opacity readings are not recorded. Emissions from ES Control C0002 are exhausted to the ambient air through Emission Point 00002.

The cremator has a sight glass where the operator can observe the cremation process and thus determine when the complete cremation process has been fully completed. Upon completion of the cremation process, the operator opens the primary chamber door and moves the cremated remains into a cooling area for final disposition. The design of the Facultatieve Technologies ISI 60 Animal Cremator is to cool down the primary chamber for approximately 60 minutes to a maximum temperature of 600° F prior to the charging of the next animal cadaver.
