State Superfund Site Partial Delist and Reclassification Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). DEC has determined that this site (see map on reverse side) no longer presents a threat to public health or the environment and is proposing to delist a large portion of the site from the Registry for the following reason(s):

- The implemented soil remedy for the site successfully achieved the Preliminary Remediation Goal for polychlorinated biphenyls in accordance with the 2006 *Record of Decision*.
- An environmental easement has been recorded for the site and limits site use to commercial and/or industrial purposes.
- A 5.25-acre portion of the site will remain on the New York State Registry of Inactive Hazardous Waste Sites and will be reclassified from Class 02 to Class 04. The Class 4 site will include the groundwater treatment area on the western and west central portion of the former industrial area, and the treatment area that overlies the west-central portion of the industrial area.
- DEC will maintain a Site Management Plan to address all on-site environmental media, and periodic reviews will be performed to confirm that site Institutional and Engineering Controls (IC/EC), are being implemented and remain effective.

Public comments are being received before the decision to partially remove the site from the Registry is finalized. The public comment period will end **August 3, 2025**. A summary of any comments will be assembled and made available for viewing at the DEC Central Office in Albany. A summary of comments received can also be obtained by contacting the Project Manager following the close of the comment period.

If we do not receive any new or additional information during this public comment period that changes our delist proposal, we will delist a portion of the site (and reclassify the remainder) on or after **September 3, 2025**.

If you own property adjacent to this site and are renting or leasing your property to someone else, please share this information with them. If you no longer wish to be on the contact list for this site or otherwise need to correct our records, please contact DEC's Project Manager listed above.
