# Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the 145-40 155<sup>th</sup> Street site ("site") located at 145-40 155<sup>th</sup> Street, Jamaica, NY. Please see the map for the site location.

**Draft Investigation Work Plan:** The draft investigation work plan, called a "Remedial Investigation Work Plan," (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by WF Industrial VII, LLC ("applicant") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

**How to Comment:** NYSDEC is accepting written comments about the Draft RIWP for 30 days, from **October 9 through November 8, 2024**

**Highlights of the Proposed Site Investigation:** The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Based on the previous investigation conducted at the Site, the primary contaminants of concern for the Site are Chlorinated Volatile Organic Compounds (cVOCs).

Key components of the investigation work include:

- Drilling and sampling soil borings to identify possible on-site sources of contamination;
- Collecting soil vapor, sub-slab soil vapor and indoor air samples; and
- Installing and sampling ground water wells to monitor impacts from areas of concern both on-site and off-site.

**Next Steps:** NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

## **BROWNFIELD CLEANUP PROGRAM**

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a "Draft Remedial Action Work Plan" will be developed. The cleanup plan will include an evaluation of the proposed site remedy, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description: The site is located at 145-40 155th Street in the Springfield Gardens neighborhood of Queens, NY, on the city block bound by 145th Road to the north, 155th Street to the east, 145th Drive to the south, and Queens Block 15002 followed by 153rd Court to the west. Adjoining and surrounding properties include single- and multi-story buildings occupied by airport hotels and industrial and commercial occupants. John F. Kennedy International Airport is located about 900 feet south of the site across the Nassau Expressway. Residential areas, consisting of 1-2 story multi-family houses are located about 550 feet east of the site along 157th Street, and about 800 feet north of the site.

The interior of the Site building will be demolished and renovated for commercial or light industrial uses. The proposed renovation and end use is consistent with the existing zoning and the recent development in this area of Brooklyn.

Brownfield Cleanup Program: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives (SCOs) or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.


