

Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the Taylor Apartments II site ("site") located at 125 River Street, Troy, Rensselaer County. Please see the map for the site location.

Draft Investigation Work Plan

The draft investigation work plan, called a "Remedial Investigation Work Plan," (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by Taylor II LLC ("applicant") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

How to Comment

NYSDEC is accepting written comments about the Draft RIWP for 30 days, from **January 21 through February 20, 2026**.

Highlights of the Proposed Site Investigation

The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Previous investigations have detected semi-volatile organic compounds (SVOCs) and metals in soil on site.

Key components of the investigation work include:

- Drilling and sampling soil borings to identify possible on-site sources of contamination;
- Collecting soil vapor and indoor air/sub-slab soil vapor samples; and
- Installing and sampling ground water wells to monitor impacts from areas of concern both on-site and off-site.

Next Steps

NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a “Draft Remedial Action Work Plan” will be developed. The cleanup plan will include an evaluation of the proposed site actions, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description

The Taylor Apartments II site is bounded by Congress Street to the north; River Street to the east; Division Street to the south; Front Street to the west, and; is bifurcated by Ferry Street (aka Route 2). The mixed-use zoned site has approximately 540 feet of water frontage along the Hudson River (across Front Street). The site consists of a 2.95-acre portion of a 3.23-acre parcel. Currently, the northern and southern portions of the site each contain unoccupied residential structures identified as John P. Taylor Apartments Buildings 3 and 4, respectively. A one-story garage structure is located in the Building 4 area. The remaining portions of the site consist of paved parking areas, maintained yard areas and concrete walkways. Previously, the site was used for various commercial and industrial facilities from at least 1893 until 1954, including several coal storage facilities and warehouses; a railroad spur and power station; blacksmith; upholstery; pork packing; automotive paint and supply; scrap and junk yards; and printing facilities.

Anticipated use of the site is for residential apartment and commercial space. The redevelopment of the Site will include construction of two, six-story towers containing a total of 308 affordable housing units located above sub-grade parking areas. Building 2 (current Building 3 area) will include approximately 2,000 square feet of ground-floor retail. The project requires the demolition of the currently unoccupied Taylor 3 and 4 towers.

Brownfield Cleanup Program

New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
