Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the 1440 Main Street site ("site") located at 1440-1458 Main Street, Buffalo, Erie County. Please see the map for the site location.

Draft Investigation Work Plan

The draft investigation work plan, called a "Remedial Investigation Work Plan," (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by 1440 Main Street LLC ("applicant") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

How to Comment

NYSDEC is accepting written comments about the Draft RIWP for 30 days, from **March 11 through April 10, 2026**.

Highlights of the Proposed Site Investigation

The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Previous investigations have detected semi-volatile organic compounds (SVOCs) and metals in soil on site.

Key components of the investigation work include:

- Drilling and sampling soil borings to identify possible on-site sources of contamination;
- Collecting soil vapor, sub-slab soil vapor and indoor air samples; and
- Installing and sampling ground water wells to monitor impacts from areas of concern on-site.

Next Steps

NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a “Draft Remedial Action Work Plan” will be developed. The cleanup plan will include an evaluation of the proposed site actions, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description

The site is approximately 1.43-acres in size and is located in an urban area at 1440-1458 Main Street in the City of Buffalo, Erie County. It is located on the west side of Main Street between Glenwood and Woodlawn Avenues. The site is mostly vacant and is covered with asphalt, light vegetation, and storage buildings. The 1440 Main Street parcel is developed with two structures, including a two-story vacant building (Building 5) and a warehouse building (Building 4). The 1458 Main Street parcel is developed with three structures including three single-story buildings (Buildings 1, 2, and 3). Previously, the site had been used as storage, a plumbing shop, storefronts, and various auto garages from about 1925 through about 1951. A former radio station studio was located on the site in 1951. One gasoline underground storage tank (UST) was identified at the northwest corner of Building 4 on the 1440 Main Street parcel in about 1925. One additional gasoline UST was identified on the southwest portion of the 1458 Main Street parcel. A survey document of 1432 Main Street, dated 1946, indicates the presence of two 750-gallon gasoline USTs in connection with a private filling station.

Planned redevelopment and anticipated cleanup have not yet been determined.

These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
