

Appendix A: Resolutions







Dear Commissioner Seggos:

This letter is to convey to you our very strong desire to see the State of New York continue to pursue the 2016 UMP Amendments to the Adirondack Travel Corridor. The State should not and cannot allow the court's decision to be the final chapter in the conversion of the travel corridor to a multi-purpose trail.

Since the adoption of the 1996 Unit Management Plan Amendment for the Travel Corridor, the New York State Snowmobile Association has held a Temporary Revocable Permit (TRP) for use of the Travel Corridor from Remsen to Lake Placid as a snowmobile trail. This trail is without question the most important snowmobile trail in the entire Park connecting many other trails with a central corridor trail from Lake Placid to points west of Big Moose. The 2016 UMP amendment with the call for the removal of the rails created the potential for a much longer snowmobile season in the eastern reach of the corridor and promised greater economic returns in the communities of Tupper Lake, Saranac and Lake Placid.

The New York State Snowmobile Association strongly supports the 2016 UMP Amendments and urges you to urge the Governor to find an expeditious way through the Court's decision and to implementation of the 2016 UMP amendment.

I am commenting today for the Adirondack Park Local Government Review Board (APLGRB).

We want to applaud Governor Cuomo, Commissioner Seggos, and all DEC staff for their vision, imagination, and diligence in bringing forward an ambitious UMP for this Corridor.

The APLGRB, passed a resolution against the removal of the rails. Many of the concerns cited for the resolution remain today. We are aware that DEC, as always, attempted to design the UMP against challenges.

The following is a list of some of these concerns;

- 1) Once the rails are removed, will an advocacy group successfully block motorized use (snowmobiles) from Wilderness designation lands the corridor runs through? Thus eliminating a use that is important to our culture and economy.
- 2) This, simply put is an UMP. It has big ideas, that we can support. However there is no known resources dedicated to this project. The people of the Park see this as a promise to improve their Towns. If resources are not allocated it will be viewed as another broken promise.
- 3) The Tupper Lake to Lake Placid multi use trail Corridor has many similarities to the Community Connector Trails. The decision out of the Appellate Court on destroying timber, and that all trees are timber, appears to the APLGRB as an additional hurdle to undertaking this project.

We hope that this plan can be implemented and be successful, that the State is willing to defend this plan and create the use they anticipate in this UMP
