The Division of Materials Management staff have reviewed your client's resubmission of the application dated May 13, 2022, for a Solid Waste Management permit to construct and operate a new C&D Transfer facility. Following are the additional comments:

- 1) Figure 6C fails to depict how trucks utilizing the overflow storage area will unload in the building. The traffic flow for unloading should be included with consideration for trucks queuing in the truck staging area.
- 2) In the bottom right corner of Figures 6A, 6B, and 6C a space is labeled as 'potential overflow truck parking & container storage area.' Please clarify if this space is intended to be used and if so, how.
- 3) The licenses provided for the disposal facilities intended to be used have expired. Please provide updated licenses for the facilities you intend to use.
- 4) In the event rail access is interrupted the waste may encroach into the tipping area during peak flow times, leaving the tractor trailers unable to use doors 1 and 5. Please revise the facility manual and Figure 6b with an updated contingency plan for an interruption in rail access.

Please revise the application site plans and documentation accordingly. Upon receipt of the revised items (three copies), an electronic copy, and a redline version depicting changes made, processing of your client's application will continue.

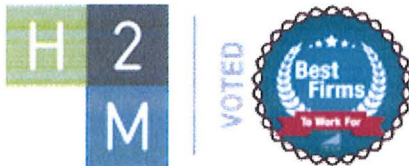
