Guidelines for Eligibility and Accounting for Disadvantaged Communities in Clean Water, Clean Air and Green Jobs Environmental Bond Act of 2022 Spending

The Clean Water, Clean Air and Green Jobs Environmental Bond Act of 2022 (Bond Act) includes several provisions related to disadvantaged communities (DACs). This document serves as guidance to implementing New York State agencies and entities charged with administering Bond Act funds.

Disadvantaged community means communities that bear burdens of negative public health effects, environmental pollution, and climate change impacts, and possess certain socioeconomic criteria or comprise high-concentrations of low- and moderate-income households. Disadvantaged communities are identified pursuant to ECL § 75-0101(5) of the State's *Climate Leadership and Community Protection Act*.

Guidance for achieving disadvantaged community provisions:

In accordance with the Bond Act, the New York State Department of Environmental Conservation (DEC) and any New York State agency, authority, or entity charged with administering Bond Act funds is to make every effort practicable to achieve a goal that 40 percent of Bond Act funds benefit disadvantaged communities provided that disadvantaged communities shall receive no less than 35 percent of the benefit of the Bond Act funds. Compliance with the 35 percent DAC mandate shall mean 35 percent of the overall \$4.2 billion Bond Act spending statewide. However, all practicable efforts shall be made to reach the goal of 40 percent of Bond Act funds benefit disadvantaged communities under each Bond Act allocation category.

To ensure compliance, New York State agencies, authorities, and entities implementing the Bond Act shall use the interpretations of the following terms used in this guidance:

- "Relevant programmatic resources" means the investment or spending through open enrollment and application-based programs, grants, competitive solicitations, or other spending funded in whole or in part through the Bond Act.
- "Benefits of spending" or "benefits of Bond Act funds" means the dollar value of relevant programmatic resources allocated through programs and projects funded in whole or in part through the Bond Act.
- "Bond Act entities" means the DEC and any state agency, authority, or entity charged with administering Bond Act funds.

The Bond Act requires investments in DACs to ensure at least proportionate benefit of the funds are realized in areas of the state that face higher burdens and vulnerability across environmental, public health, socioeconomic, and climate factors.

Please note: New York State is committed to uplifting all communities. While the Bond Act requires a specific investment in DACs, all communities statewide are eligible to receive funding. This guidance does not eliminate Bond Act entities' ability to make program decisions to benefit those most in need based on their own determinations, including but not limited to DACs. All eligible entities are encouraged to apply for Bond Act funding opportunities.

Prioritization for disadvantaged communities in Bond Act eligibility

In order to facilitate compliance with the 35 percent DAC benefit requirement, Bond Act entities shall design their eligibility and scoring criteria so that relevant programmatic resources encourage participation by disadvantaged communities. All practicable efforts shall be made to reach the goal of 40 percent of Bond Act funds benefit disadvantaged communities under each Bond Act allocation category.

Bond Act entities may direct benefits or other beneficial outcomes to DACs through various program design or implementation considerations including, but not limited to:

- increasing outreach and engagement to grow or otherwise improve enrollment or initiation of Bond Act projects in DACs;
- assessing and addressing barriers and opportunities for DACs in program design; and
- establishing DAC-specific eligibility and/or evaluation criteria for relevant programmatic resources.

Programs funded in whole or in part through the Bond Act will serve New Yorkers across a broad range of environmental and climate needs from open space, air and water quality, flood risk reduction, restoration projects, clean energy, and more. Therefore, specific DAC eligibility, scoring, and other criteria should be tailored to fit each program. Entities should incorporate DAC criteria in a way that best serves their specific operational needs and goals of their programs, while also driving proportionate benefits to DACs. To ensure consistency across all Bond Act programs, Bond Act entities will work with DEC's Office of Environmental Justice (OEJ) to develop and finalize DAC eligibility criteria in their Bond Act programs.

Guidance for prioritizing DACs in competitive solicitations

Bond Act entities administering Bond Act funds via competitive solicitations shall establish DAC-specific eligibility criteria for all relevant programmatic resources. The DAC map and population matrices (Appendices A and B) effective at the time of application for a grant opportunity will be used to calculate scoring.

Criteria to be implemented for relevant programmatic resources may include, but are not limited to:

- prioritizing DACs through the scoring process by using a graduated scoring system based on the density of the DAC population served;
- reducing or eliminating, to the extent practicable, the inclusion of similar and potentially duplicative criteria used prior to the designation of DACs (e.g., hardship community, underserved population, Low Moderate Income, Environmental Justice community, federal DAC designations);
- requiring applicants to provide a narrative of how DACs will benefit from their proposals;
- requiring applicants to conduct public engagement with DAC stakeholders and outline engagement plans in their proposals;
- screening applications for potential benefits to DACs, such as inclusion of evaluators with a working knowledge of the DAC criteria; and/or
- requiring evaluations or reports submitted back to the Bond Act entity include an assessment on progress in DACs.

Guidance for prioritizing DACs in first-come, first-served programs

Relevant programmatic resources that are allocated on a first-come, first-served basis will aim to maximize benefits to DACs in line with the 40 percent goal. To promote DAC benefits in Bond Act programs with first-come, first-served allocations, Bond Act entities are advised to consider:

- requiring applicants to provide a narrative of how DACs will benefit from their proposals;
- awarding higher allocation amounts for applications that will benefit DACs; and/or
- releasing relevant programmatic resources in a schedule to allow for evaluation of program and adjustments to program based on DAC participation.

Guidance for prioritizing DACs in place-based programs

Relevant programmatic resources that are place-based or can be directed at projects whose impacts can be localized to a defined geographic area shall make all practicable efforts to reach the goal of 40 percent of Bond Act funds benefit disadvantaged communities. Place-based projects located in a DAC are presumed to be beneficial to DACs unless otherwise indicated in an application or proposal. Place-based projects not located in a DAC are presumed to not generate benefits to DACs unless otherwise indicated in an application or proposal and approved by the Bond Act entity. However, because the DAC criteria excludes census tracts that have very low populations, such as parks or outdoor recreational areas, Bond Act entities may consider place-based projects directly adjacent to DACs in their prioritization and assessment of DAC benefits by identifying the project service area and calculating the DAC population benefitting from the project. To promote DAC benefits in Bond Act programs with place-based allocations, Bond Act entities are advised to consider:

- prioritizing DACs through the scoring process;
- reducing or eliminating, where possible, the inclusion of similar and potentially duplicative criteria used prior to the designation of DACs (e.g., hardship community, underserved population, Low Moderate Income, Environmental Justice community, federal DAC designations); and / or
- allowing project applicants from outside of DACs to specify whether their proposed project will benefit adjacent DACs.

Guidance for prioritizing DACs in community-wide programs

Relevant programmatic resources allocated under the Bond Act may be made at the municipality or county level (community-wide) in accordance with the provisions of the Bond Act and pursuant to any programs administered by or agreement with Bond Act entities. Therefore, Bond Act entities will consider the density of the DAC population in prioritizing DACs in Bond Act program proposals.

DEC and the New York State Energy Research and Development Authority (NYSERDA) have developed a matrix (Appendix A) estimating the density of the DAC population in every municipality in New York State. Appendix B provides an estimate of DAC population in each borough of New York City.

Bond Act entities are required to use the matrices (Appendix A and B) to develop scoring and eligibility criteria for relevant programmatic resources that will be allocated community-wide. Scoring and/or evaluation of relevant programmatic resources to be allocated community-wide will account for density of the DAC population served (e.g., municipality with a larger DAC population density receives more points than a municipality with a lower DAC population density).

Additional considerations for Bond Act entities to promote DAC benefits, where applicable, in community-wide Bond Act programs include, but are not limited to:

- requiring applicants to conduct public engagement with DAC stakeholders and outline their engagement plans in their proposal;
- requiring applicants to provide a narrative of how DACs will benefit from their proposals to be used for informational purposes by Bond Act entities; and/or
- requiring evaluations or reports submitted back to the Bond Act entity to include an assessment on progress in DACs.

Accounting for disadvantaged communities in Bond Act spending:

All Bond Act entities are required to maintain an inventory of all relevant programmatic resources allocated to be reported to DEC. The inventory will include, but is not limited to, information regarding allocations intended to benefit DACs or that have the potential for delivering benefits or other positive impacts for DACs. DEC will measure DAC benefits from the Bond Act as set forth below.

Accounting requirements for Bond Act entities

Relevant programmatic resources that are place-based or that can be directed to projects or individuals whose impacts are localized wholly within a disadvantaged community will account for the full amount of their award/allocation as a DAC benefit upon execution of a grant contract with the Bond Act entity awarding Bond Act funds. For place-based Bond Act projects located outside a DAC but determined by the Bond Act entity to serve DACs, DEC will use the project service area approved by the Bond Act entity to calculate the DAC benefit.

Relevant programmatic resources allocated community-wide will be accounted for commensurate with the expected benefits to DACs, using the proposal submitted by the awardee and/or the DAC population matrices (Appendix A and B) as a guide. Table 1 provides examples of accounting for place-based and community-wide programs.

For proposals that are neither place-based nor community-wide, or proposals that span parts of multiple communities, the Bond Act entity will map the project service area to calculate the DAC population benefitting from the project. The DAC map and population matrices (Appendices A and B) effective at the time of application for a grant opportunity will be used to calculate the benefit.

The DAC criteria are reviewed annually by New York State's Climate Justice Working Group, and the working group may vote for changes to DACs during such review. Therefore, tracking and accounting for DAC investments shall be calculated at the time of contract based on an analysis of the project service area with the DAC map and population matrices (Appendices A and B) effective at the time of application for a grant opportunity. The financial calculation to determine what portion of funding is counted toward DAC benefits will be calculated based on the percentage of the project serving DACs as shown in table 1 below.
