

Per our conversation last week, I am sending you the Vehicle Dismantler report. To recap our conversation, we operate school buses, a repair garage and tow trucks. In the past, we would get stuck with smashed vehicles and not have title to them. The process to properly dispose of these vehicles was long and costly. The Town of Sheldon then cited us with operating a junkyard and took us to court. Someone suggested a Vehicle Dismantler Permit and received no more citations.

To this day we still get stuck with such vehicles and also accept a vehicle, with title, as partial payment for people with no collision insurance. We then haul the vehicle away when price of scrap is up and is convenient for us.
